## IMPORTANT INFORMATION

### PROOF OF IDENTITY

If you are changing your **name** or **birthdate** you will need to provide at least **ONE** of the following:

- A certified copy of:
  - Birth certificate; or
  - Citizenship/Naturalisation certificate; or
  - Marriage certificate; or
  - Divorce certificate; or
  - Change of Name certificate
- A certified photocopy of a card issued to you under a law of a State or Territory for the purpose of proving your age which contains your photograph; or
- A certified photocopy of your national identity card issued by a foreign government, the United Nations or an agency of the United Nations.

### WHO CAN CERTIFY COPIES OF ID

All copies of ORIGINAL ID documents must be certified as true and correct copies by any of the following:

- Justice of the Peace (including Commissioner for Declarations),
- Police Officer
- One of the following with two or more years of continuous service:
  - Australia Post permanent employee
  - Financial Institution Officer (e.g bank employee)
  - Australian Financial Services Licensee (AFSL) authorised representative or officer
- Notary Public Officer
- Registrar, deputy registrar or judge of a court
- A person enrolled on the roll of a State or Territory Supreme Court or the High Court of Australia, as a legal practitioner
- An Australian consular officer or an Australian diplomatic officer



- A magistrate
- A Chief Executive Officer of a Commonwealth court

**Please note:** You should not send original forms of documents. These should be retained for your records. Only send certified **copies of originals**. Copies that are not certified will not be accepted.
